## Spring Cleanup

The ILWA spring cleanup will be held on **Sunday, May 1st from 9am to Noon**. Goals for the day include cleanups at Morgan Park, Frosthalm Memorial, Hapgood-Brooks Memorial and the public beach. Please bring rakes, shovels, gloves and trimmers if possible and meet at Morgan Park at 9am. Groups are welcome!

## Frosthalm Memorial

The ILWA prides itself not only on lake and shoreline improvements but also improvements and issues that relate to our neighborhood as a whole. Members of the ILWA have long taken care of the Frosthalm War Memorial which is located across from Strand's Ski Shop on West Boylston Street. This memorial was donated many years ago by the Salloway Family of Salloway's Market to honor our World War II veterans from Greendale. Unfortunately, most of the names were lost when the display case deteriorated long ago and the landscape is in need of improvement.

The ILWA recently developed a project plan for the Frosthalm Memorial in cooperation with the City of Worcester Parks and Veteran's Services Departments. The plan involves adding pathways, benches and landscaping to this highly visible location. Extensive research will have to be done by volunteers to replace the names on the memorial.

About 2 weeks ago, we completed a grant application to the Nathaniel Wheeler Trust seeking funds for landscaping. Provided we are successful in getting monies through Wheeler, we will be looking for individuals and businesses

## 319 Status

The City of Worcester Department of Public Works has secured an engineering firm to design the underground catch basins that will be installed at three to four locations around Indian Lake. This is a critical piece to reducing the sediment and other runoff that has long been entering Indian Lake. Installation is currently expected late summer or early fall.

We are anxiously awaiting the opportunity to examine the plants that were installed last year as part of the pilot plant replacement program funded through the 319 grant. This piece of the project is being watched statewide as a potential non chemical solution to the invasive weed problem facing many lakes throughout New England.

## Water Quality Monitoring

With the installation of the sedimentation systems mentioned above, water quality monitoring by the ILWA is no longer required by the DEP for the purpose of the 319 grant, however, we are currently planning on continuing the monitoring twice a year starting with **Saturday, May 14th**. We will need individuals to collect samples and perform the testing in the conference room which is graciously donated by Griggs & Browne. ## Proposed Boat Ramp Move

In the fall, a meeting was held by the Worcester Parks & Recreation Commission to examine the possibility of moving the boat ramp from Morgan Park to Shore Park. Let me assure you that this is not set in stone and there will be future meetings to review the design ideas and improvements that would be made to both facilities if this were to move forward.

Some of the ideas that are being considered for Shore Park are a separate gated entrance to the boat ramp that would only be for boat launching with "swim deterrent" rocks surrounding it.

Morgan Park would become "car top only" (canoes and kayaks) and in place of the current boat ramp, a handicapped accessible fishing pier may be installed. It is becoming clear that the ongoing problems at

Morgan Park stem from **Take & pick up trash** a facility not large enough to handle it. On the other hand, we DO NOT want to see the same problems moved to Shore Park.

The current boat ramp is in need of replacement. The state is looking at which options make the most sense. We don't anticipate a quick decision. We will keep you posted as we learn more.
